PUBLIC SERVICE ANNOUNCEMENT FROM THE WINDOW ROCK DISTRICT COURT AND SUPREME COURT OF THE NAVAJO NATION

The Window Rock District Court and Administrative Office of the Courts buildings in Window Rock, Ariz., are closed Friday, October 22, 2021, until further notice. The Navajo Nation Supreme Court is closed beginning Thursday, October 21, 2021, at 4:20 p.m. until further notice.

The Window Rock District Court will be operating out of its hearing room at the Butler building next to the Navajo Nation Vital Records Office and by telecommuting. All court hearings will be held by teleconference until further notice. The Window Rock District Court may be contacted by telephone at (928) 206-7469 or by email at nnwrcourt@navajo-nsn.gov.

In-person filing will not be available until further notice. Documents may be filed with the Window Rock District Court by email, fax, mail, or drop box. Faxes may be sent to Dilkon Judicial District at (928) 657-8146 until further notice. Documents filed with the Window Rock District Court by email, fax or drop box outside regular court hours will be received the next business day.

The mailing address for the Window Rock District Court is P.O. Box 5520, Window Rock, AZ 86515.

The preferred method of contact for the Supreme Court at this time is email to nnsu.gov. Faxes sent to the Supreme Court will not be received until the building is reopened. Telephone messages left at the Supreme Court telephone number will not be checked or returned until the building is reopened. The drop box for the Office of the Chief Justice is also not available until further notice. Filings are not accepted through the Office of the Chief Justice drop box.

The Navajo Nation uses a sender verification system designed to eliminate spam, bulk and malicious emails. If you email the courts from a non-Navajo Nation email address, make sure to verify your email address by following the instructions sent back to you by email. This will allow for your email to go through to the intended recipient.

To pay any fine or fee, mail a money order payable to the "Navajo Nation" to the mailing address. Include citation/court document and contact information. All fines or fees mailed will be processed as received on the postmarked date.
