- Encourage interaction and engagement to include participation as a requirement. Engagement is encouraged to avoid sleepiness and to keep audience captivated. Some presentations would run too long or go off topic.
- Keep up the physical activities before and after the sessions
- I have learned so much. So much information was given and good to be aware of, but the session was too long. Need to get some ice breakers done between sessions. Add some traditional and cultural hands-on activities. Need to have rules limiting cell phones; turn them off because it is really distracting.
- Name for committee: Dine' Movement to Empower Dine' Nation or even translate: Na'asgo' dziil bee vii'kah.
- How will the TAP help the veteran community? A veteran advocate should be on the planning committee.

- I would like to comment that the workshop was very very informational. I like that there was a variety of services and all the way to youth. I wish there was more time for some panel discussion.
- Exciting endeavor. Overall, good job. May be helpful to provide supporting documents beforehand. May be helpful to prioritize issues; there's a lot of issues which can become overwhelming. Include first responders, DPS, and others.
- This was an excellent beginning to bringing together Tap participants. Providing the background information is important. Thank you. I think this is also an excellent way to inform the Navajo Nation workforce involved that this is important and many people care. The support of Navajo Nation administration is invaluable. I think periodic get-togethers (day meets) to check progress will be helpful.
- Thank you Yvonne and staff. It was an inspiration to hear from our Dine' youth and Navajo Nation leaders.
- From one day's observation, it appeared that there was a common agenda by all. Keep the momentum going.
- A true awakening.
- Continue to round table work sessions; they are helpful in allowing multiple disciplines to express their point of views; it also allows an exchange of current events and happenings across Navajo.
- For round table work, it would be very helpful to have a facilitator assigned to groups so that the work stays on task.
- Please provide more time for panel; more than 15 minutes.
- Too many people on the panel and not enough time.
- Chapter, Regional meetings monthly/quarterly.
- Meet every two years for follow-up, as a whole.
- Divide everyone equally all departments sit with co-workers so split up everyone randomly so a dialogue could take place between departments and organizations.

- Let's get veterans involved! It's very disappointing that no Navajo Nation liaisons were on site. Where were they?
- The Veterans were not mentioned or represented.
  These heroes also deserve services to address their
  needs. Which could include; substance use, mental
  health, housing, food, medical care. Please include
  the Veterans.
- Need more Navajo leaders from Navajo Nation council and legislature should be present.
- Invite Tribal leaders
- Sessions were too long.
- Speakers need to maintain time line of presentations (3).
- Invite youth council youth ambassador.
- Smaller rooms to hold conferences.
- Better technology for PowerPoints, etc.
- Audio-Visual material made available beforehand to ensure material is followed.
- Tech problems were challenging (2).
- Speakers to focus on TAP to maintain interest of the target audience.
- Please acknowledge our relatives who do not speak or understand the Navajo language, by providing lecturers in Navajo and English.
- If we are not flexible we could be risking a valuable resource for our Navajo Nation – I met relatives from: Zia, Pueblo, Hopi, Spanish, Anglo, as well as younger people who do not speak or understand our Navajo language.
- I realize this is a Navajo Tribal workshop, but I do not speak Navajo. I was unable to understand quite a lot of what was said. I work in this area and want to learn more about the culture and language.
- Teaching the Navajo language is not an easy task. I
  would suggest that the OP/VP make the Rosetta Stone
  program available to all Navajo people. It would be
  easy and an important first step that would show the
  support of the OP/VP. Everything else would be more
  resource intensive.
- Maybe add another day.
