# RESOLUTION OF THE NAVAJO NATION COUNCIL

#### 22nd NAVAJO NATION COUNCIL - First Year 2011

#### AN ACT

RELATING TO THE NAVAJO NATION COUNCIL, APPROVING A PROVISIONAL AMENDMENT TO TITLE 2 N.N.C. CREATING THE NÁBIK'IYÁTI'COMMITTEE TO FUNCTION UNTIL SUCH TIME AS THE COMMITTEE STRUCTURE OF THE NAVAJO NATION COUNCIL CAN BE AMENDED TO ACCOMMODATE THE 24 MEMBER NAVAJO NATION COUNCIL

#### BE IT ENACTED:

- 1. The Navajo Nation finds with respect to this legislation the following:
  - A) The Navajo People amended Navajo Nation Code Title 2 to provide for the reduction of the Navajo Nation Council from 88 members to 24 members; and
  - B) This decision by the Navajo People has required the amendment of Title 2 to restructure the Standing Committee system, consisting of 12 Standing Committees to a committee structure reflecting the capacities of a 24 member Council; and
  - C) It is recognized by the Court that this restructuring is the function of the 22<sup>nd</sup> Navajo Nation Council; and
  - D) The 22<sup>nd</sup> Navajo Nation Council has undertaken this extensive and complex restructuring responsibility from the very first day of the 22<sup>nd</sup> Council's Delegates taking of the oath of office and has met in work and regular session virtually continuously since that time; and
  - E) The 22<sup>nd</sup> Navajo Nation Council is required to consider and enact such amendments to Title 2 at a regular session of the Navajo Nation Council (The Navajo Nation Title Two Amendments of 1989, CD-68-89, Resolved Clause 6); and

- F The 22<sup>nd</sup> Navajo Nation Council, having met and deliberated several lengthy legislative proposals regarding restructuring during the regular session finds that it needs more time to adequately consider all the proposals before it; and
- G) The Council finds that it is precluded by law from continuing to act in regular Winter Session beyond this day, January 28, 2011. 2 N.N.C. § 162 (C) "The duration of each session shall be no more than five working days. Each meeting day of the Navajo Nation Council shall be for a minimum of six hours each day of the session"; and
- H) The 22<sup>nd</sup> Navajo Nation Council finds that it is in the best interest of the Navajo People that the business of the Nation not be unduly delayed or stopped until the legislative standing committees are restructured; and
- This continuation of governance can best be achieved by Creating the Nábik'iyáti' Committee to be composed of the entire membership of the 22<sup>nd</sup> Navajo Nation Council and temporarily exercising the powers and duties of the 12 Standing Committees as enumerated in the Title 2, for not longer than the beginning of the Spring Session beginning on the third Monday of April, 2011, in order that the business of the Navajo Nation continue unimpeded.
- 2. The 22<sup>nd</sup> Navajo Nation Council hereby amends Title 2 as follows:

# Article 20. Nábik'iyáti' Committee

# § 836. Establishment ; Purposes

The Nábik'iyáti' Committee is hereby provisionally established, and shall meet at the call of the Speaker and exercise to the extent necessary and reasonable all the powers, duties and responsibilities of the 12 standing committees of the Navajo Nation Council as enumerated in 2 N.N.C. §§ 341-835 inclusive.

- B. The Nábik'iyáti' Committee shall be composed of the entire membership of the 22<sup>nd</sup> Navajo Nation Council; the chairperson of the Committee shall be the Speaker of the Navajo Nation Council.
  - C. The authority of the Nábik'iyáti' Committee shall be in effect provisionally until the start of the Spring Session of the 22<sup>nd</sup> Navajo Nation Council which begins on the third Monday of April 2011, at which time the Committee shall cease to function as described §836 A, above.
  - D. The Nábik'iyáti' Committee shall form itself into subcommittees as needed to accomplish the Council's work for this assigned duration.

## Section 1. Effective Date

The amendments enacted herein shall be effective pursuant to 2 N.N.C. \$221(B).

# Section 2. Codification

The provisions of the Act which amend or adopt new sections of the Navajo Nation Code shall be codified by the Office of Legislative Counsel. The Office of Legislative Counsel shall incorporate such amended provisions in the next codification of the Navajo Nation Code.

## Section 3. Saving Clause

Should any provision of this Act be determined invalid by the Navajo Nation Supreme Court, or the District Courts of the Navajo Nation without appeal to the Navajo Nation Supreme Court, those provisions of the Act which are not determined invalid shall remain the law of the Navajo Nation.
