Notice is hereby provided that the above named Respondent-Appellant and Real Party in Interest and Appellant, Chris Deschene, appeals to the Navajo Nation Supreme Court from the Final Order Disqualifying Respondent entered by the Office of Hearings and Appeals in Case Nos. OHE-EC-005-14 and OHA-EC-007-14 on the 9th day of October, 2014. A true and correct copy of the Order being appealed is attached hereto as Exhibit "A," and the Office of Hearings and Appeals transmitted a certified copy to this Court on or immediately after October 9, 2014, which is incorporated herein by this reference.

The time provided for Mr. Deschene to timely file this Notice is 10-days, which does not include "the day of the act, event, or judgment . . .," N.R.C.A.P. Rule 5(a), and "[t]he last day of the period so computed is to be included unless it is a Saturday [or] Sunday . . . , in which case the period shall extend to the end of the next business day which is not a Saturday [or] Sunday" *Id.* Accordingly, this Notice is provided within time-period required.


